Committee on Discipline

Electing 2 Rostered Ministers and 2 Lay Persons, six-year terms ending 2031

The Committee on Discipline of this Synod consists of 12 persons, of whom six shall be Rostered Ministers (pastors or deacons) and six shall be laypersons, who are elected by the Synod Assembly for a term of six* years without consecutive re-election. (*Due to a year without a synod assembly, we are electing members to 5-year terms this election process.) Members of this committee may be called to participate in a hearing when charges are brought against governing officers, ministers of Word and Sacrament, ministers of Word and Service, congregations, and/or members of a congregation. (Full description in Chapter 20 of the Constitution, Bylaws, and Continuing Resolutions of the ELCA.)

Consultation Committee

Electing 2 Rostered Ministers and 2 Lay Persons, six-year terms ending 2031

The Consultation Committee consists of 12 persons, of whom half shall be Rostered Ministers and half shall be laypersons. These members are elected by the Synod Assembly for a term of 6* years without consecutive reelection. (*Due to a year without a synod assembly, we are electing members for 5-year terms this election process.) When there is disagreement among factions within a congregation on a substantive issue that cannot be resolved by the parties, members of a congregation shall have access to the synod bishop for consultation after informing the chair of the Congregation Council of their intent. If the consultation fails to resolve the issue(s), the Consultation Committee of this synod shall consider the matter. (Full description in Chapter 20 of the ELCA Constitution and Chapter 17 of the Synod Constitution.)

The council typically meets every 2 months. The Synod Council is the board of directors of this synod, serving as the legislative authority between meetings of the Synod Assembly. Additional leadership functions include trusteeship responsibilities on behalf of this synod; recommending program goals and budgets; carrying out resolutions of the Synod Assembly; etc. (See Chapter 10 of the Synod Constitution for full definition of Council.) These are each three-year terms.
